I hereby declare that I currently am:

- A solo student skydiver.
- A licenced skydiver, Polish qualifications certificate (ŚK) or licence No. .... Pursuant to the aforementioned certificate/ licence, I am authorised to perform skydives without instructor supervision.
- I am a skydiving instructor/ tandem master, Polish qualifications certificate (ŚK) or licence No. .... Pursuant to the aforementioned certificate/ licence, I am authorised to provide instruction and coaching services, and engage in commercial operations.

I further represent and declare as follows:

- I shall be participating in all skydiving activities at my own risk; in case of any incident not attributable to the Organiser of skydiving activities, I shall not take action or file any claims against the Organiser under civil law;
- I shall be participating in skydiving activities of my own free will and in conformity to my certification and skills level; I am aware that skydiving activities carry a risk of injury or death;
- If using a private skydiving rig: I declare that all papers for the rig and parachute I am using are valid and up to date, that the obligatory reserve parachute packing date has not expired, and that the overall rig condition allows safe participation in skydiving activities;
- I carry a valid and complete set of papers required to participate in skydiving activities, including valid Third Party Liability insurance I will submit to the Organiser for inspection on demand;
- I am aware of and will adhere to the content of Polish legal provisions regulating skydiving activities, and the Rules and Regulations of Participating in Skydiving Activities;
- I am aware of and able to act according to procedures of responding to hazardous situations and malfunctions;
- I am aware of the following stipulations of §41 of the Ordinance of the Minister of Transport, Construction and Maritime Economy of June 3rd 2013 regarding the qualifications certificate (Journal of Law 2017, item 288), and I shall be strictly adhering thereto:

*"§41. Flight crew members and/or flight crew member candidates in aviation training shall refrain from performing all and any flight activities in case of the following:*

- 1) *If suffering of a physical or mental ailment affecting their ability to safely perform any flight activity;*
- 2) *When under the influence of:*
- 3) *Drugs reducing mental or physical capacity,*
- 4) *Alcohol,*
- 5) *Narcotics or other psychoactive substances."*

I am fully aware that skydiving activities carry substantial potential risks, disability and loss of life in particular. I hereby declare I shall be taking all and any action to minimise said risks by strictly adhering to legal regulations in force on Polish territory, *Rules and Regulations of Participating in Skydiving Activities*, and *Training Programme* provisions. I am further aware that rescue or medical assistance cannot be provided to me during a skydive. I will only participate in skydiving activities I am skilled in, and have been trained and certified to perform. I hereby acknowledge that the majority of skydiving equipment manufacturers disclaim liability for any proper functioning of manufactured equipment by labelling their produce accordingly. They further do not warrant the proper functioning of said equipment even if operated correctly.

I hereby represent and declare that all data presented herein is correct and genuine, and relates to me. Pursuant to the Personal Data Protection Act of May 10<sup>th</sup> 2018 (*Journal of law* 2018 item 1000, as amended), I hereby consent to my personal data being included in the database, and processed for purposes required under separate legal provisions as required by the skydiving activities Organiser to engage in providing flight activities. I shall have the right to access and rectify my personal data. I hereby consent to correspondence being mailed and/or e-mailed to the address(es) I have specified to the purpose.

## INFORMATION CLAUSE

1. The Warsaw Aero Club (Aeroklub Warszawski) with its registered office in Warsaw 01-934, Poland, at Księżycowa No. 1 shall be the controller of all personal data provided, and be hereinafter referred to as *"the Controller"*. The Controller shall handle all operations involving your personal data processing.
2. Any personal data you provide will be used to purposes associated with the following:
  - Delivery of the statement/declaration serving purposes of an agreement entered into with you,
  - Seeking any potential claims or damages,
  - Responding to any letters, motions, and/or complaints you might file,
  - Responding to letters as part of any proceedings in progress.
3. The legal basis for processing your personal data has been stipulated below:
  - Indispensability for purposes of performing a skydive/ participating in skydiving activities,
  - Necessity to conform to the Controller's legal obligation,
  - Indispensability to any intent arising from legally justified interests engaged in and delivered by the Controller.
4. While providing personal data is voluntary, it is a prerequisite to performing a skydive/ participating in skydiving activities.
5. Any personal data you provide may be transferred to:
  - Entities processing your personal data and acting on our commission,
  - Public authorities and/or agencies authorised to access data under applicable legal provisions, i.e. courts of law, law enforcement agencies or other public institutions demanding access to such data on sufficient legal grounds.
6. No personal data you provide shall be transferred to third states.
7. The period over which your personal data is processed shall be determined by the respective purpose. The period over which your personal data is archived shall be determined by the following criteria:
  - Time associated with performing a skydive/ participating in skydiving activities,
  - Legal provisions potentially obliging us to process your data over a specific period,
  - The period required for us to safeguard our interests.
8. Each and every personal data subject shall have the right to:
  - Demand that the Controller provide him/her with access to aforementioned; have his/her data rectified and/or erased; request restriction to the processing of his/her data,
  - Object to his/her data being processed in a specific manner,
  - Have his/her data transferred,
  - Lodge a complaint with the Supervisory Authority, i.e. the President of the Data Protection Office,
  - Withdraw his/her consent to have his/her data processed.
9. Personal data shall not be subject to automated decision-making processes, including but not limited to profiling.

I have acknowledged the content of the aforementioned Information Clause, including information concerning purposes and forms of personal data processing, right to access personal data content, and right to rectify it.
